How many staff have been employed in the MARA in the last 5 financial years? Please provide a breakdown by section?

## Answer:

The tables below contain details of the number of staff employed broken down by section as at 30 June for each of the previous five financial years.

Information for the 2009-2010 financial year is from the Office of the MARA Annual Report.

Information prior to 1 July 2009 has been sourced from the Annual Reports of the Migration Agent Registration Authority (the Authority), which was operated by the Migration Institute of Australia. The names of sections and their respective functions may have changed over time and it is not possible to make direct comparisons with the current organisational structure.

Numbers include part time staff. Where there was a vacancy the actual number of staff is shown in brackets. IT contractors are included in the figures as at 30 June 2010 and earlier for consistency.
