The Department routinely liaises with councils on matters relating to the Australian Citizenship Ceremonies Code, for example the Department has conducted regular face to face information sessions with councils in relation to the Code. Departmental staff in the State and Territory offices also liaise regularly with individual councils (including by email, telephone and face to face) on the implementation of the Code as required.

The Government would in particular like to draw your attention to the following chapters:

• chapter 7 which sets out the policy concerning inviting government representatives to citizenship ceremonies;

- chapter 9 which sets out the three legal requirements for conducting a
 citizenship ceremony. This chapter also sets out the policy concerning the
 use of holy books. Candidates should be informed in their invitation letters
 that, should they wish to use a holy book or scripture to make the pledge, they
 should bring it to their citizenship ceremony.
- chapter 10 which sets out the policy concerning reading the Minister's message and speeches by official guests; and
- chapter 12 which sets out the policy concerning the need for the pledge verification list to be signed and returned promptly. This chapter also sets out the policy concerning disclosing names and addresses of new citizens.

The Government thanks you for your continued support of Australian citizenship.
