Senator Cash asked:

1) How many onshore applications for student visas were made in the 2009/10 financial year by subclass and in the year to date? 2) What was the refusal rate for applications in those periods for each subclass? 3) How many visas were granted? In which subclasses? How does this compare with 2007-08 and 2008-09?
