#### **Question No. 144**

#### Senator Humphries asked the following question at the hearing on 12 February 2013:

### **Provision of Equipment**

- 1. For departments/agencies that provide mobile phones to Ministers and/or Parliamentary Secretaries and/or their offices, what type of mobile phone is provided and the costs.
- 2. For departments/agencies that provide electronic equipment to Ministers and/or Parliamentary Secretaries and/or their offices, what are the ongoing costs for this financial year to date?
- 3. Is electronic equipment (such as ipad, laptop, wireless card, vasco token, blackberry, mobile phone (list type if relevant), thumb drive) provided to department/agency staff? If yes provide details of what is provided, the purchase cost, the ongoing cost and a breakdown of what staff and staff classification receives it.
- 4. Does the department/agency provide their Ministers and/or Parliamentary Secretaries and/or their offices with any electronic equipment? If yes, provide details of what is provided, the cost and to who it is provided.

## The answer to the honourable senator's question is as follows:

1. The Attorney-General's Department provides various mobile phone devices (including BlackBerry devices) to Ministers and their staff as required. The type of device provided is dependent on a number of factors including availability at the time of purchase and the business requirements of the user (eg mobile phone only or mobile phone and data/emails etc). The average purchase price of a new BlackBerry device is approximately \$500 each.

The following Blackberry devices are currently in use within AGD:

- BlackBerry 8800
- BlackBerry 9000
- BlackBerry 9700
- BlackBerry 9780
- BlackBerry 9790
- BlackBerry 9800
- 2. Ongoing costs for electronic equipment provided to Ministers and their offices for this financial year to date include the following (all figures are GST exclusive):

- \$55,990 Mobile phone communication expenses (mobile phones and BlackBerry's)
- \$13,332 Data communication expenses (wireless internet, tablet devices etc)
- \$16,200 BlackBerry support-related expenses
- 3. The Attorney-General's Department provides the following electronic equipment to staff as required to assist them with carrying out their duties:
  - Laptop
  - Citrix remote access token
  - Wireless internet dongle
  - BlackBerry device
  - Mobile phone
  - iPad
  - iPhone
  - Bluetooth headset
  - Bluetooth car kit
  - USB storage device
