Question No. 5

Senator Ludwig asked the following question at the hearing on 24 May 2006:

- a) Not including 'data lists' previously provided to the committee on CD-ROM, can the Department provide the committee with all materials relied on by the Department in developing advice to the Attorney-General on suitable locations for Family Relationship Centres, including, but not limited to, all information, recommendations or minutes provided by the Department of Families, Community Services and Indigenous Affairs.
- b) Can the Department provide the committee with the final advice given to the Attorney-General on locations for Family relationship Centres.

The answer to the honourable senator's question is as follows:

- (a) In addition to the data already provided, which includes population data, demographic information and ABS mapping, the Attorney-General's Department relied on staff assessments of accessibility of the proposed Family Relationship Centres to people elsewhere in the region and adjacent regions, including location of transport and service hubs. The assessment was through discussion rather than in written form. The Attorney-General's Department also relied on input from the then Department of Family and Community Services (FaCS). That input was in three forms:
 - i. oral (through discussion of possible locations, including comment on suitability and location of other services)
 - ii. FaCS's rankings of locations under consideration, based on its draft needs analysis for the Family Relationships Services Program, and
 - iii. emails containing FaCS's opinions on matters of policy relating to our advice to the Attorney-General.

The documents provided by FaCS containing rankings are attached. It would not be appropriate to release the emails from FaCS as they disclose opinion relating to policy advice to the Attorney-General.

(b) The final advice of the Department to the Attorney-General is not available as it discloses policy advice to the Attorney-General in relation to his consideration of the location of the Family Relationship Centres.
