I am writing to correct evidence that was provided to the Senate Supplementary Budget Estimates hearing of the Senate Legal and Constitutional Legislation Committee on 23 May 2006 in relation to Outcome 2 of the Immigration and Multicultural Affairs portfolio.

I refer in particular to evidence provided under Outcome 2.1, in response to a question from Senator Hurley in relation to the provision of child care under the AMEP contracts. I indicated that the contractual requirement is that child care "be available no more than 20 minutes travel from where the English language tuition is provided". The contractual requirement in fact refers to 30 minutes and that number should therefore be corrected to 30 minutes. Please pass to the Committee my apologies for this error.

I apologise for any difficulties that my error may have created for the committee.


