Senator Hurley (L&C 22) asked:

What was the contract amount for the southern area and the northern area of New South Wales? Could you also give me the contract amount for the remaining 18 service providers?

*Answer:*

The estimated value of each contract for the contract period, as published on the AusTender website (<http://www.contracts.gov.au>), is set out below. Humanitarian Programme numbers for each year are determined annually. Estimated contract values are based on the assumption of entrant numbers for each year of the life of the contract being the same as the projected 2005-06 numbers. Actual expenditure will vary by the number of entrants accessing IHSS services, and the extent of services utilised.
