### **Question No. 29**

### Senator Crossin asked the following question at the hearing on 31 October 2005:

Please provide a copy of correspondence seeking comment on the draft text of the Convention on the rights of people with Disabilities.

### The answer to the honourable senator's question is as follows:

On 30 September 2005, letters jointly signed by the Attorney-General's Department (AGD) and the Department of Family and Community Services (FaCS) were sent to relevant Australian Government agencies, State and Territory Governments through the Standing Committee on Treaties (SCOT) officials and the Standing Committee of Attorneys-General (SCAG) officials, and organisations from the disability, human rights, legal and business sectors. The letters advised of progress since the previous round of consultations and plans for ongoing consultation. The template letter is included at **Attachment A**.

On 24 October 2005, subsequent to the release of the Chair's Text, further joint AGD-FaCS letters were sent to relevant stakeholders.

The letters to Australian Government agencies sought general comments on the Chair's text, and also nominated some Departments as having lead agency responsibility for preparing briefings on particular articles of the Chair's Text. The template letter to Australian Government agencies is included at **Attachment B**.

The letters to SCOT and SCAG officials sought a single whole-of-Government response for each State and Territory. The template letter to SCOT and SCAG officials is included at <u>Attachment C</u>.

The letters to the human rights, legal, and business groups sought general comments on the text and/or articles of particular interest to their organisation. The template letter to these groups is included at **Attachment D**.

The letters to organisations within the disability sector also advised that the Australian Federation of Disability Organisations would be consulting with them under the terms of the \$50,000 grant approved by the Attorney-General in October 2005. The template letter to disability sector groups is included at **Attachment E**.

# Draft Comprehensive and Integral International Convention on the Protection and Promotion of the Rights and Dignity of Persons with Disabilities

We write to update you on work underway in the United Nations on a *Comprehensive and Integral International Convention on the Protection and Promotion of the Rights and Dignity of Persons with Disabilities* (Convention). This letter also advises of the next steps in the process to develop the Convention which will involve widespread and time-critical consultation, and to request that you nominate a contact for this purpose urgently.

As part of a broad consultation process, we are also writing to other relevant Australian Government agencies, State and Territory Governments, as well as stakeholders among the disability sector, human rights, business and legal groups.

### **Background**

An Ad Hoc Committee was established by the United Nations General Assembly in December 2001 to consider proposals for a Convention, and to this point there have been six sessions, the most recent being held from 1 August to 12 August 2005.

Australian Involvement in the Ad Hoc Committee Sessions

Australia has been actively involved in the development of the draft Convention. The Australian Government has sent an official delegation to each session of the Ad Hoc Committee. Delegation members include Australian Government agency representatives and representatives of the Human Rights and Equal Opportunity Commission (HREOC) and the disability sector.

The Attorney-General's Department (AGD) and the Department of Family and Community Services (FaCS) have consulted with other Australian Government agencies, State and Territory Governments, the disability sector, and human rights, legal and business groups. The responses to the consultations have informed the development of the Australian Government's position on its participation in the UN process as well as the briefing of Australia's official delegations.

#### Outcomes from the Ad Hoc Committee Sessions

The initial meetings of the Ad Hoc Committee examined options for an instrument, and established a working group comprising states, non-government organisations and one national human rights institution to develop a draft text. A first reading of the working group's draft text was completed at the third session. Over the course of the fourth, fifth and sixth sessions, members of the Committee negotiated the text and made various proposals for textual amendment. At the sixth session, the Ad Hoc Committee completed its second reading and recommended that it hold two sessions in 2006 of between 10 and 15 working days each during January and August 2006.

### The Next Steps

Chair's Text

At the conclusion of the sixth session, the Chair of the Committee indicated his intention to release a 'Chair's text' during October 2005. The Chair's text will take account of the negotiations to date, and will be the subject of the third reading of the text during the January 2006 meeting. Outstanding issues of difference would be finalised at the August 2006 meeting.

In order to inform development of the Australian Government's position prior to the third reading of the text, time critical consultations will be necessary. Consequently, we will seek the views of the relevant stakeholders as soon as the Chair's text becomes available.

### Briefings on Draft Articles

The delegation will require a comprehensive briefing on each article of the Chair's text. AGD and FaCS will coordinate this. However, we will be asking agencies to provide input and in some cases to prepare and coordinate briefs. It is proposed that upon receipt of the Chair's text, lead agency responsibility for each article will be assigned to relevant Australian Government agencies. Lead agencies will be responsible for providing a briefing on the particular article using a template to be provided by AGD, and will most likely incorporate input from State and Territory Governments and the disability sector. The briefings will require Branch Head level clearance.

Set out below is a list of the articles in the draft Convention as at the end of the sixth session. Although the names and numbers of the articles may change, it is expected that the overall content of the articles will not change significantly.

As we indicated previously, timing for preparations for the next stage of negotiations is very tight – the UN Ad Hoc Committee will meet in January 2006. This letter seeks your agency's:

- Contact officer [delete if contact officer already nominated]
- Participation in an inter-departmental committee (IDC) meeting on a date to be arranged
- General comments (if any) on the Convention by Monday 28 November 2005, and
- Brief as lead agency on draft articles within your responsibility by Wednesday 7 December 2005.

These steps are explained further below.

Two-Step Consultation Process

Your assistance is sought in a two-step consultation process. In the <u>first step</u>, we seek your general comments on any draft article in which your portfolio may have an interest. The <u>second step</u> of the process is to prepare briefings on each article of the Chair's Text. We will provide all general comments received from stakeholders among the disability, human rights, legal and business sectors, as well as State and Territory governments and relevant Australian Government agencies to the nominated lead agency for consideration in developing the briefing on each draft article. The briefings will then be compiled by AGD and FaCS into one consolidated briefing package for the Australian delegation.

#### Lead Agency Responsibility for Briefings

The delegation to the next session of the Ad Hoc Committee will rely on briefings on each article as their instructions for negotiations. Lead agency responsibility for each article has been assigned to an Australian Government agency on the basis of that agency's portfolio responsibility or primary expertise and familiarity with the subject matter of the article. Lead agencies are asked to provide briefing on the article using the template provided at **Attachment C**. Briefings will need to consider the views of State and Territory Governments (who may ultimately be responsible for implementation), and key stakeholders such as the disability sector. The briefings will require Branch Head level clearance.

Your agency has been nominated as lead agency for Article [insert number of article] which relates to [insert subject of article]. (Please advise us urgently if you do not agree with this nomination). It may be helpful to review the previous draft article and briefing on education which related to the earlier draft. They are included for your information at <u>Attachment D</u> and <u>Attachment E</u> respectively.

Negotiations at the seventh and eighth sessions will seek to finalise the text for presentation to the UN General Assembly. The Chair of the Ad Hoc Committee has requested that the text be considered on the basis of what would be <u>acceptable</u> rather than <u>preferable</u>. Briefing should therefore focus on:

- whether the text would be acceptable
- if there is text that would be unacceptable, and
- if so, that you provide instructions for the necessary changes that would allow the delegation to negotiate an acceptable text.

For your information, a full listing of the agencies assigned lead agency responsibility for each article is included at <u>Attachment F</u>. The first column contains the number of the article in the Chair's Text with the corresponding number of the article in the previous draft included in brackets. The lead agency listing contains an additional column which lists agencies that we consider would have an interest in the draft article.

### **Timeframe**

Our letter of 30 September 2005 indicated that the timeframe for the consultation and briefings processes would be extremely tight. The seventh session of the Ad Hoc Committee will be held in January 2006 in New York. Given the holiday season and the Christmas closedown period, sufficient time will need to be allowed to:

As foreshadowed in our letter of 30 September 2005, the Chair's Text on the *Comprehensive and Integral International Convention on the Protection and Promotion of the Rights and Dignity of Persons with Disabilities* (Convention) has been released.

As we indicated previously, timing for preparations for the next stage of negotiations is very tight – the UN Ad Hoc Committee will meet in January 2006. We now seek your comments on the draft text through participation in national disability sector consultations.

We are pleased to advise that the Attorney-General has approved a grant of \$50,000 to the Australian Federation of Disability Organisations (AFDO) to undertake nationwide consultations with the disability sector on the Chair's Text.
