## Question No. 74

### Senator Ludwig asked the following question at the hearing on 31 December 2005:

- a) Regarding the Urban Search and Rescue Capabilities are WA, SA, Tas and the NT still classed as developing capabilities?
  - (i) if not, when did they cease to be classed as developing capabilities?
  - (ii) If so, what is the timeframe for completing the upgrade of these capabilities?
  - (iii) Has EMA finished procuring equipment for this capability?
  - (iv) How far away is EMA from establishing a national USAR capability?
- b) Regarding the gaps that EMA identified in SA, NT, ACT and Tas at the last estimates have you finished procuring the basic equipment for these states?
  - (i) If not, when do you expect to do so?
  - (ii) If so, when did you finish doing that?
  - (iii) What was the total cost of the procurement of the basic equipment?
  - (iv) What was the originally projected cost of this equipment?
  - (v) Has the equipment been provided to the states?
- c) Could you indicate how much of the \$15million that the Federal Government provided as part of its cost-sharing burden has been expended?
  - (i) Could you provide a breakdown?
  - (ii) Has any additional funding been requested?
  - (iii) If so, how much and when was it requested?
- d) Could you indicate what work EMA is continuing to do with the non-developing states (Qld, NSW, Vic)?
- e) What sort of liaising are you doing with them?
  - (i) Is it primarily expert advice, or providing resources?
- f) Are you continuing to monitor their training programs to ensure they are up-to-date with what is required?
