Training sessions varied from four hours to two days in duration depending on the course content.

The NTS is a program funded by the Department to assist Migrant Resource Centres/Migrant Service Agencies and organisations funded under the Community Settlement Services Scheme to manage and deliver settlement services. The program comprises three modules:

Module 1: The Community Settlement Services Scheme

Module 2: Managing the Community Settlement Services Scheme

Module 3: Effective Management Skills for Community Based Programs

Modules 1 and 2 are intended for Management Committees and Project Workers.

Module 3 is intended for Management Committee members. Training was also run in relation to the following:

- Financial Management;
- Making Meetings work;
- Pro-active Communication;
- Strategic Planning;
- Dealing with Difficult Clients;
- Milestone Reporting and Casework.

Training was conducted either by Departmental staff or by training professionals.

The modules are run regularly throughout the year and are open to all organisations. Organisations attend based on need and skills.
