(24) Output 1.1: Non-Humanitarian Entry and Stay

Senator Ludwig (L&C 7) asked:

Provide the number of people who are issued student visas, how many travel to Australia and how many never take up the visa and then, of those that do come to Australia, how many complete their studies and go home, how many go home before completing their studies (and why), how many transfer to another visa category (eg. Humanitarian, student, permanent residency) and when during their studies do they transfer to this category, how many have their visas cancelled and are removed from Australia.

So basically, what happens to each person who gets a student visa to come to Australia in terms of if and when they leave Australia and the circumstances in which they leave (*this question was provided by Senator Ludwig after the Committee Secretariat sought his clarification*).

Answer:

Statistics on the timing of international students' movements to other visa categories or to their home country, and the reasons for their movements at the level of detail requested would involve a very major diversion of resources to collect. However, statistics based on aggregate movement provides a reasonable approximation. These are provided below.

Change of Status from Student Visa

DIMIA records that as at 30 September 2005, some 70 persons who arrived at any time on a student visa were granted initial protection visas in the 2004-05 program year.

In addition, approximately 16,600 student visa holders were granted General Skilled Migration visas, some 2,661 former student visa holders were granted Family Stream visas and another 301 were granted Employer Sponsored Permanent Residence visas. Some student visa holder would have obtained other temporary resident and/or visitor visas.
