SUPPLEMENTARY BUDGET ESTIMATES HEARING: 19 OCTOBER 2010

IMMIGRATION AND CITIZENSHIP PORTFOLIO

(349) Program 1.1: Visa and Migration

Senator Cash asked:

- (1) What kind of bona fide checks are undertaken in high risk posts?
- (2) Which posts are they?
- (3) What is the current overstayer rate of visitors from those overseas posts?
- (4) How does this compare with the past three years?

Answer.

In regards to parts (1) and (2) of this question and historic data relating to parts (3) and (4), I refer Senator Cash to the response to question 123 at Additional Budget Estimates of 9 February 2010.

3. Table 1 provides the five countries with arrivals of more than 5000 with the highest Modified Non Return Rate (MNRR) in 2009-10.

The MNRR is a calculation of the percentage of visitors who have arrived, whose initial visa has expired within the reporting period and either remain in Australia unlawfully, who have departed Australia on an expired visa, or who have applied for a subsequent visa other than visas that are deemed to be of benefit to Australia.

The global average MNRR in 2009-10 was approximately 0.75 per cent.

Table 2 provides the five countries with arrivals of more than 5000 with the highest overstayer rate in 2009-10.

^{*}The Department uses Modified Non Return Rates (MNRR) to determine which case loads represent high risks.

The overstayer rate is the number of non-citizens who overstayed their temporary visa (excluding Bridging E visas) by more than 14 days within the financial year as a percentage of the total number of temporary entries for that year.

The overall overstayer rate in 2009-10 was approximately 0.35 per cent.
