b) Service Standards

For the twelve months ending 31 October 2011, the median processing time to decide a first Working Holiday (Subclass 417) visa application was same day – that is they were processed on the same day they were lodged. In comparison, the median processing time for the twelve months ending 31 October 2010 was also same day.

For the twelve months ending 31 October 2011, the median processing time to decide a second Working Holiday (Subclass 417) visa application was four calendar days. In comparison, the median processing time for the twelve months ending 31 October 2010 was five calendar days.
