Australian Crime Commission

1)Yes

- a) Four
- b) One bulk volume shredder @ \$8,840, Three shredders @ \$2,980, excluding GST.
- c) This equipment was purchased to meet business requirements for secure destruction of classified material.
- d) Shredders are used for the destruction of classified documents in accordance with the *Australian Government Protective Security Policy Framework*.

- a) Seven.
- b) Two shredders @ \$2,980, One shredder @ \$2,347, Four shredders @ \$2,040, excluding GST.
- c) This equipment was purchased to meet business requirements across the regional sites for secure destruction of classified material.
- d) Shredders are used for the destruction of classified documents in accordance with the *Australian Government Protective Security Policy Framework*.

Australian Customs and Border Protection Service

- d) Shredders are used to destroy classified material that does not need retention to meet business, archival or broader relevant needs, and so reduce unnecessary storage requirements and the potential compromise risk associated with retention of unnecessary copies of such material.

- b) Each shredder had a unique purchase price, however, the average cost of the shredders purchased since 1 May 2012 was \$4,627.00 each.
