### SENATE STANDING COMMITTEE ON LEGAL AND CONSTITUTIONAL AFFAIRS COMMONWEALTH DIRECTOR OF PUBLIC PROSECUTIONS

#### **Question No. 94**

#### Senator Siewert asked the following question at the hearing on 16 October 2012:

1. Penalties for Social Security fraud

For the financial year 2011-12:

- a) How much of the Director of Public Prosecutions financial resources (amount and percentage) was dedicated to social security fraud?
- b) How many staff working on projects related to social security fraud?
- c) How many convicted for social security fraud?
- d) For the financial periods 2011-12 provide a breakdown of the sentencing outcomes of recipients convicted by the CDPP by type of sentence (eg. custodial sentence, good behaviour bond, community service order, etc) and provide a breakdown of sentencing outcomes by type of income support payment, age; gender: state and territory, and Indigenous/non-Indigenous background
- e) For all custodial sentences, detail the length of sentences and the value of the fraud involved.
- 2. Social Security Fraud Convictions

For the 2009-10, 2010-11 and 1 July 31 2011 to 30 June 2012 provide a breakdown of people:

- a) convicted of social security fraud by payment type.
- b) convicted of social security fraud by payment type and gender.
- c) convicted of social security fraud by state and territory and the amount for each jurisdiction.

#### The answer to the honourable senator's question is as follows:

1. Penalties for Social Security fraud

For the financial year 2011-12:

- a)In 2011-2012, 41.1% of defendants dealt with before the courts were referred by Centrelink.. CDPP resource usage is provided below.
- b)CDPP resource usage as at 30 June 2012: 182 CDPP staff had open Social Security fraud files.
