NOTICE OF REVOCATION/DECLARATION OF SECURITY CONTROLLED AIRPORT AND AIRSIDE AREAS – SYDNEY AIRPORT CORPORATION LIMITED AIRPORT





'INTERNATIONAL PRECINCT AREA'




