Senator Milne asked:

Will you take on notice a question to the Tasmanian department: At what point did they know that a devil with Devil Facial Tumour Disease was found dead in proximity to the park? Let us establish first when and how they knew that that dead animal was near the park. Exactly where was the dead animal? I am very happy to know that.

Answer:

The Australian Quarantine Inspection Service (AQIS) has written to the Department of Primary Industries and Water Tasmania seeking answers to the questions as to exactly when, where and how the devil in question was found and when did the Tasmanian Department receive the information. Once the reply is received, more information will be provided to the Senate Rural and Regional Affairs and Transport Legislation Committee.

Revised answer received 18/02/2008:

On 15 March 2007, AQIS wrote to the Department of Primary Industries and Water (DPIW) Tasmania, seeking answers to the questions as to exactly when, where and how the devil in question was found and when did the Tasmanian Department receive the information. Advice was received from DPIW Tasmania on 25 June 2007 which stated the following:

"A dead devil with DFTD was found on 19 July 2004 in the Lake Rowallan area, which is some kilometres south of where Trowunna Wildlife Park is located. A departmental officer submitted this devil to Mt Pleasant Laboratories where it was diagnosed as having DFTD.

DPIW officers were advised on 25 October 2006 that in June 2006 a live wild male devil was trapped in the proximity of Trowunna Wildlife Park, just outside of the park's perimeter fence. This wild devil was found to have DFTD. Trowunna Wildlife Park is set adjacent to an area of bushland that acts as a wildlife corridor. Since the park was established it has been normal to have evidence of wild devil activity outside the perimeter fence. The wildlife park owner indicated that a trap had been set outside the perimeter fence to look for any evidence of DFTD in wild devils in the area."

Mr Yuile—We would have the data with respect to white-spot syndrome because of the testing regime there. I can see what other data we have. My memory is about 80-odd per cent of consignments are clear and 20 per cent are rejected, but I will double-check that for you.
