Mr Hurry—I would be reasonably sure that that is not the case, Senator, but I am happy to check it for you.

Senator O'BRIEN—I recall a Senate inquiry about just that fact, but perhaps I have imagined it. It will not take much to look up the inquiry.

Mr Hurry—I am happy to do that, and I will also go back and check the main sources of supply of fisheries research from Commonwealth funding, but I think it is still reasonably robust, because it is a mix of Commonwealth, institutional and state agency funding that goes into fisheries research and trying to develop a better understanding of stock structures in Australia.

Answer:

Fisheries research funding was not withdrawn during the mid-late 1990s and a search of the register of Senate Committee Reports revealed no evidence of a Senate inquiry that matches that described by Senator O'Brien.

There was one for the Southern Shark Fishery, there was one for the South-East Trawl Fishery, and then there is the major package that is under way at the moment, the Securing Our Fishing Future one. One of those may have been before that 10-year period, but I have a sense that one of them was around the time of the creation of AFMA.

Senator O'BRIEN—What about the Northern Prawn Fishery?

Mr Hurry—I would need to check that. There may well have been one for the Northern Prawn Fishery, but it may well have been before then.

Mr Talbot—There was one for the South-East Non-Trawl Fishery at the same time as the Southern Shark Fishery.

Answer:

The Structural Adjustment Packages put into effect for Commonwealth managed fisheries over the last 10 years are as follows:

- South East Trawl Fishery an adjustment package was introduced in 1997 to stabilise the fishery associated with allocation of quotas. The package took out 27 trawl licences for \$1.714 million and 16 operators received \$2.297 million in financial assistance in a program the total cost of which was \$4.2 million.
- In 1999 a \$2.6 million Southern Shark Industry Development Program was announced. This programme was undertaken in 2000/01 with the purpose of smoothing the transition to individual transferable quotas. The total cost of the program was \$1.9 million and 40 permits were bought out. Also over 200/01 the South –east non-trawl fishery was also subject of an industry development program which expended \$0.346m buying blue-eye trevalla quota units to address allocation issues.
- Securing our Fishing Future the most recent adjustment package applying to Commonwealth managed fisheries that are subject to overfishing, was put into effect between 2005 and 2007. To date there have been more than 550 fishing concessions surrendered across all Commonwealth managed fisheries at a cost of \$148 million. - The Australian Government, in conjunction with the Queensland Government and the Torres Strait Regional Authority, is implementing a programme to adjust allocation in Torres Strait fisheries to account for obligations to Papua New Guinea

Other packages have primarily involved adjustment of state managed fisheries. This includes packages administered by the Commonwealth environment portfolio such as the Great Barrier Reef Marine Protected Area Structural Adjustment Package in 2004 - 05 and an earlier East Coast Trawl Fishery voluntary buyback scheme in 2001 to facilitate a reduction in fishing effort in the Great Barrier Reef World Heritage Area.

The Department of Agriculture, Fisheries and Forestry (DAFF) has a contract with Seafood Services Australia (SSA) for the provision of the 1800 number service, including monitoring and reporting. The current contract is for 31 July 2006 – 30 June 2007.

For the period 1 August 2006 to 31 January 2007 there were 57 calls received. During the previous contract with SSA for the provision of the hotline, which ran for the 2005 calendar year, there were 107 calls received.

The SSA refers reports to the hotline to the relevant state or territory agency, as the states/territories are responsible for compliance and enforcement of food labelling requirements. It is not mandatory for the states and territories to report to the SSA or the Australian Government on action, investigations or prosecutions arising from calls to the hotline. No formal information on investigation or prosecution action has been received from the states or territories under the current arrangements. The Australian Government will be discussing with the states and territories a mechanism for reporting on the outcomes of actions taken in relation to both previous and future calls to the 1800 number service.

Additional activities include working in partnership with Indigenous people, government agencies and the forest industry to encourage skills development, employment and business opportunities.

In relation to the Cyclone Larry projects involving the clearing of fallen timber, the crews are contracted on a commercial basis through Northern Skills Alliance Inc., under the Operation Farm Clear Program. Crew members work for money.

The Department of Agriculture, Fisheries and Forestry (DAFF), Treasury and the Australian Taxation Office also consulted regularly with industry until the Government announced its decision on 21 December 2006.
- b) It was a combination of a formal consultation process undertaken by Treasury based on a call for submissions from interested stakeholders, and ongoing consultation between Treasury, the Australian Taxation Office, Department of Agriculture, Fisheries and Forestry and industry.
- c) The formal consultation process formally ran from 9 May 2006 to 14 July 2006, with regular consultation also undertaken with industry until the announcement on 21 December 2006.

In 2006/07, the Forest and Wood Products Research and Development Corporations received approximately \$7,499,271.

Under the new arrangement for funding it is anticipated that additional funding of approximately \$2 million will be available to Forest and Wood Products Australia for marketing and promotion activities.
