#### Senator Milne asked:

According to an AMSA media release dated 27 March 2001, AMSA 'assumed responsibility for the search for a missing Indonesian fishing boat believed to be about 40 to 50 nautical miles (70 to 90 kms) north of Christmas Island... and ships in the area have been advised by AusSAR to be on the look out for the missing boat... A spokesman for AuSSAR said the Indonesian search and rescue authority BASARNAS and the Indonesian Embassy in Canberra had been advised of the incident'.

- a.) What action was taken by AMSA in relation to the rescue at sea of this suspected illegal entry vessel?
- b.) will the Minister provide all records that are held by AMSA in relation to the rescue of this vessel including a copy of the incident file & reports to BASARNAS and the Indonesian Embassy? and
- c.) will the Minister provide all records of telephone conversations held by AMSA in relation to the rescue of this vessel?

#### **Answer:**

a) AMSA's Rescue Coordination Centre (RCC) was advised at 9.09 am Christmas Island time (12.09 pm EST) on 27 March 2001 by the police on Christmas Island about a local fishing boat rescuing two Indonesian fishermen from a makeshift raft. The fishermen reported that the day before they had left an Indonesian fishing vessel with approximately 20 people on board that had broken down and had been drifting for several days to the north of Christmas Island and it no longer had food or water on board. The Christmas Island police advised they had tasked another vessel in the area and an aircraft from Christmas Island to search for the fishing vessel.

The RCC issued a broadcast to shipping to keep a lookout for the fishing vessel. In case the police coordinated search did not find the fishing vessel, the RCC undertook some contingency planning by checking the availability of search assets, including checking with Coastwatch and the RAAF, checking the weather forecast for the search area with the Bureau of Meteorology and preparing drift planning.

After the aircraft from Christmas Island conducted the initial search and did not report having located the fishing vessel, the RCC accepted overall coordination of

the search and rescue operation at the request of the Christmas Island police from 1.36 pm Christmas Island time (4.36 pm EST) on 27 March 2001.

As Christmas Island is in the Indonesian internationally recognised search and rescue region, the RCC sent a facsimile to the Indonesian search and rescue authority, BASARNAS, and asked if it would undertake coordination of the search. The facsimile also was copied to the Department of Foreign Affairs and Trade and the Indonesian Embassy in Australia. BASARNAS replied requesting RCC Australia to assist with the search and rescue of the fishing vessel.

The RCC tasked the aircraft from Christmas Island to undertake another search in the afternoon of 27 March 2001. Shortly after the aircraft left Christmas Island, it reported locating the fishing vessel. The Christmas Island police arranged for the police rescue vessel to rendezvous with the fishing vessel. The Christmas Island police confirmed the safety of the 22 people on board and that the fishing vessel was seaworthy, so it could be towed to Christmas Island. The Christmas Island police then accepted transfer of the overall coordination of the search and rescue operation from the RCC.

#### **Answer:**

AMSA does not maintain a separate record of suspected illegal entry vessels that have required rescue operations or that have been subject to a broadcast to shipping.

AMSA's Rescue Coordination Centre processes in excess of 10,000 incidents annually, with approximately 500 requiring search activity. AMSA would have to examine each incident to establish if it involved a suspected illegal entry vessel. This would represent a significant and inappropriate diversion of AMSA resources from its safety responsibilities.
