The minister's attendance at the Community Cabinet meeting held on 28 July 2009 in Elizabeth, South Australia was not combined with visiting additional industry sites, however it was combined with additional destinations. These additional destinations are unable to be disaggregated from the Community Cabinet travel. The minister's travel costs for this meeting totalled \$1749.39 ^{1,2}.
