Senator HUMPHRIES: You say that two-thirds of the beneficiaries have been Indigenous. Why do you think it is, then, that the president of the Australian Indigenous Art Trade Association, Ian Plunkett, has said that Aboriginal artists are being disadvantaged under the scheme because of the way it has been set up......

Senator HUMPHRIES: Can I suggest that you might like to talk to that organisation and understand their concerns?

Mr Eccles: We have been talking to Indigenous arts organisations, I think, to take it on notice as to whether or not this particular individual has been party to discussions.

Answer:

Mr Plunkett was involved in stakeholder discussions with the Department prior to the resale royalty scheme's introduction and with the Collecting Agency, Copyright Agency Limited (CAL) during the scheme's establishment. CAL reports that it has regular ongoing contact with Mr Plunkett by phone, in person and by email.

CAL also reports that feedback from Indigenous artists about the scheme has been positive. For example, Jane Young, Indigenous artist and Chairperson of DesArt, the association of central Australian Aboriginal art centres, has said 'some Aboriginal artists don't have much money, and for some people in communities the money they make from art is the only money they get, so this resale royalty is really good. It is good that the money is coming back to the artist because they made the work. It's their story that they are telling'.

- give the Minister the capacity to prescribe a format of a notice of a commercial resale; and
- define 'sufficient detail' for the purposes of reporting by art market professionals.

Terms of reference

The National Cultural Policy will set the framework for Australian Government support for arts, culture and the creative industries for the next ten years. The objective of the policy is to increase the social and economic dividend from the arts, culture and the creative industries. A strong artistic sector producing the highest quality work results in positive social and economic impacts for the nation. The funding delivered to the arts through the Australia Council ensures that high calibre artistic product is made for Australian audiences.

The Australia Council's original purpose was:

to ensure "the best is encouraged and those who produce it are given the greatest opportunity to achieve the highest quality of which they are capable" (*Nugget Coombs*).

The review should assess whether the original purpose remains relevant today. The review will determine the appropriate governance and administrative model to ensure the Australia Council is able to:
