**Ms Christie:** I am sorry; I do not have the detail of the grants for the literary publication.

**Senator ABETZ:** All right. If you can take that on notice.

### **Answer:**

Magazines and journals are eligible to apply in three grant rounds: Program Grants, Publication Grants and Key Organisations. The total allocation of funding for magazines and journals varies each year according to Board assessment of each application. In 2012-13, the Literature Board will be allocating approximately \$520,000 towards magazines and journals.

**Senator ABETZ:** Can I tell you: at arm's length from the Australian taxpayers as well who have shown their support for Quadrant, and other organisations that do not have that sort of readership, do not have that sort of support base in the Australian community and seem to get bucket loads of money. Meanjin, for example, sells how many copies per edition? Can you tell me that?

Ms Christie: No, I cannot, I am sorry.

**Senator ABETZ:** Take that on notice for us and let us know why that particular literary magazine (Meanjin) is a key organisation which gets triennial funding.

**Answer:** 

To be eligible for a grant, a magazine/journal must have sales/subscribers of at least 500 copies per issue. This information is provided as proof of eligibility but is not a criterion for assessment.

All funding applications, supporting materials and acquittal materials, including subscription numbers, are submitted to the Literature Board in confidence and are not released to the public.

Following a competitive Expression of Interest process from the Literature Board in 2010, Meanjin was invited to submit an application to be considered a Key Organisation.

Meanjin was successful in this process along with three other literary magazines/ journals: Griffith Review, Australian Book Review and Overland.

- evidence of a high level of achievement and leadership in the development of programs to support and promote Australian writers and Australian literature.

The Australian Book Review is funded as a Key Organisation 2011-13. In this category there is no criterion which requires the journal to review all significant Australian published trade books.

The criteria for Key Organisations are as follows:

The quality of the proposed three-year program and the opportunities it provides for professional development of Australian writers;

Effective management of resources, with an achievable three-year plan that includes strategies for building resources and diversifying income;

Evidence of a high level of achievement and leadership in the development of programs to support and promote Australian writers and Australian literature; and

The calibre of the personnel involved in the organisation and proposed program.

Funding is granted towards fees for contributing writers and journal costs.
