**Mr Aldred**—I suspect it is. I must admit I have not got my 2006-07 PBS with me so I will have to take it on notice. I can provide the shifts in funding there. From recollection, it may actually be on the Hansard. I may have advised the committee of those changes previously, but I will check.

#### **Answer:**

In the 2006 Federal Budget, \$300,000 from the National Landcare Programme (NLP) National Component was re-profiled from 2005-06 to 2006-07, leaving the 2005-06 NLP National Component appropriation at \$7.922 million.

At the same time, \$1.2 million was re-profiled from 2007-08 to 2006-07. The combined transfers of \$1.5 million brought the 2006-07 NLP National Component appropriation to \$11.722 million.

Perhaps if you give me those figures that will help me assess that.

#### **Answer:**

For the National Action Plan for Salinity and Water Quality, State and Territory governments match the total Australian Government funding in cash.

For the Natural Heritage Trust, State and Territory governments match the total Australian Government funding in cash or in-kind. In-kind funding is agreed through the Joint State and Australian Government Steering Committee. It is expected that in-kind funding is relevant to the outcomes of the Trust.

As part of the development of National Climate Change Adaptation Framework the Australian Greenhouse Office commissioned CSIRO to review current information on the impact of climate change on marine ecosystems, fisheries and aquaculture. The report is publicly available at

In October, 2007, the Australian Fisheries Management Forum conducted a workshop to develop a National Interim Climate Change Response Plan for Fisheries and Aquaculture. The workshop was attended by representatives from the Commonwealth and all states, and included officers from policy, management and research bodies.

Outcomes from the workshop will inform the development of a national climate change action plan for the fisheries and aquaculture sector as recommended in the National Climate Change Adaptation Framework that will form the basis for determining, mitigating and adapting to the effects of climate change in the sector.
