Answer:

Under the funding agreement between the Australian and Victorian Governments for the *Sustainable Groundwater Management project*, a report on assistance measures to help address the impacts on irrigators of declining water levels in the Latrobe Aquifer must be completed by December 2007.

The issues associated with the Latrobe aquifer are complex and full hyrdrogeological investigations, including modelling, will be required to support a management plan for the Latrobe groundwater resource. The investigations are due to be completed in mid 2008 and a management plan for the Latrobe Aquifer is due to be completed by the end of 2008.
