The @GIS now supports three Tableland Councils' IT infrastructures and manages all of their GIS data sets. They are also engaged in several core projects being undertaken by the Shire Councils:

- including the Integrated Services team responsible for the design and implementation of integrated services across the Shires as part of the State Government's *Size*, *Shape and Sustainability* program.
- The Asset Management Team, which has carriage of standardising technical, financial and spatial asset data sets and asset management systems across the Shires.

The @GIS continues to develop and maintain practical relationships with the Natural Resource Management (NRM) groups of the wider northern region including the development of a data-share agreement and process between the NRM groups and the Region of Council groups.
