#### Answer:

The five National Sporting Organisations (NSOs) affected by the 2012-13 MYEFO decision of October 2012 include the Australian Football League, Australian Rugby League, Australian Rugby Union, Football Federation Australia and Cricket Australia. These NSOs have received their full 2012-13 funding allocation for illicit drug education under the Illicit Drugs in Sport (IDIS) program, and will carry forward unexpended funds from 2012-13 into 2013-14. These NSOs will be increasing their own contributions to build upon their existing programs, and to allow their illicit drug education programs to continue into the future.

**Senator HUMPHRIES:** With respect to the 2011-12 funding, yes, I accept that. Can you say to me with confidence that after those cuts in the 2012-13 budget and MYEFO the level of testing of athletes in Australian sport did not go down?

Senator HUMPHRIES: Yes.

Mr Eccles: We will take that on notice.

#### Answer:

The funding reduction in the 2012-13 Budget and following the 2012-13 MYEFO decision of October 2012 did not directly impact on athlete testing, as the Commonwealth funding was provided for illicit drug education programs. The affected National Sporting Organisations are expected to continue their athlete testing programs from within their own resources.

**Senator Lundy**: Absolutely not, Senator Humphries. I do not think there is a correlation at all. We have described in some detail and have taken on notice other details about the nature of that budget reduction. But in the meantime there is a whole list of things that we have strengthened as we seek to harden up the environment and support sports to protect their athletes. We are very happy to go through the recent strengthening of the National Integrity of Sport Unit if you would like us to describe what those measures are.

Senator HUMPHRIES: Thank you but I will take that offer on notice...

## Answer:

Following the release of the Australian Crime Commission's Project Aperio, an additional \$1.7 million was provided to expand the capability of the National Integrity of Sport Unit (NISU).

The funding provides for the building of a more proactive integrity threat identification and assessment capability within the NISU and the provision of advisory services for sport and the government. The expanded NISU will also deliver expert assistance to individual sports to help them establish and maintain robust integrity policies.

The NISU is examining a range of issues which impact upon the integrity of Australian sport, both nationally and internationally. It is leading the national response at both the Commonwealth and state and territory levels on a range of issues including:

- co-ordinating and negotiating outcomes with states and territories to ensure a consistent national legislative approach on match-fixing though the implementation of the National Policy on Match-fixing in Sport;
- leading the Government response to the Australian Crime Commission 'Project Aperio' report into new generation performance and image enhancing drugs and their use in professional sport in Australia;

**Mr Eccles:** They are very different in terms of the business models that they operate under. In terms of the Cricket World Cup, the International Cricket Council makes a significant contribution to the host organisation, the host local organising committee, whereas, for the Asian Cup, there is no such contribution made by the Asian Football Federation.

**Senator Lundy:** Senator Humphries, the Cricket World Cup, too, is also in partnership with New Zealand so that is, I think, a factor. Also these commitments were initially conveyed under the previous government so we are following up what is essentially a bi-partisan commitment to both events.

**Senator HUMPHRIES:** Okay. Could I ask you to give us a template showing both events what dollars are coming from what areas directly and indirectly for both events from the Commonwealth level. What do you understand to be the state support both direct and indirect?

**Senator HUMPHRIES:** You cannot tell me how that \$55.7 million breaks up in terms of the agencies as between what they are doing to support the Asian World Cup versus the Cricket World Cup?

Mr Eccles: No. We will take it on notice. It has been some time since Australia has hosted a multicity major event like this. In there is nothing in recent times that is commensurate to it. The funding that came on for the Asian Cup for these agencies was first. They, by necessity, had to build up a particular capability. The flow-on funding they required to deliver their guarantees for cricket was going to be less because of the established capability that was able to be derived from the initial injection of funding, if that makes sense.
