**Senator Lundy:** That is just a matter of looking at the Crawford review and then looking at Pathway to Success. We are happy to go through it in detail here, but it is all a matter of public record and it has been on the public record for several years.

**Senator HUMPHRIES:** As I say, I did not think that you had put on the record exactly whether you had implemented these recommendations or not, but perhaps I will put this on notice

- 1. Prior to the allocation of \$2.8 million to the Major Sporting Events Taskforce in MYEFO, what was the annual budget for the taskforce?
- 2. How many FTE staff positions work in the Taskforce?
- 3. Please provide the terms of reference for the Major Sporting Events Taskforce?
- 4. What are the objectives of the Major Sporting Events Taskforce?
- 5. What are the criteria applied by the Department to determine which sporting events are considered 'major' and therefore provided assistance by the Taskforce?

#### **Answer:**

- 1. Prior to the allocation of \$2.8 million to the Major Sporting Events Taskforce in MYEFO, the annual budget supporting major events was \$1.1 million per year over three years.
- 2. Up until November 2012, there were five FTE staff positions. This will be increased by a further six as a result of additional funding provided pursuant to MYEFO of \$2.8 million.

#### 3. & 4.

The Major Events Taskforce has been established within DRALGAS to coordinate the Australian Government's involvement in the 2015 Asian Football Confederation (AFC) Asian Cup, the 2015 International Cricket Council (ICC) Cricket World Cup, and the 2018 Gold Coast Commonwealth Games.

Its role is to coordinate the operational support the Commonwealth will provide in support of these events and to coordinate with state and territory governments. The Taskforce works closely with the organising committees to ensure event planning is closely aligned with operational planning.

- 5. The Taskforce plays a role in those events which require Commonwealth operational support (e.g. national security, immigration support, commercial rights protection) as part of their delivery.
- 6. The Cricket World Cup 2015, the 2015 AFC Asian Cup and the Gold Coast City 2018 Commonwealth Games.
- 7. The Taskforce comprises DRALGAS employees and is not representational. A governance framework exists which provides for the Taskforce to work closely with other Commonwealth agencies and state governments.
