Addendum [Brad Parfitt] 18 Mar 09 The actions against a emerging Political Party attempting to draw attention to serious infringements on Human Rights at Gawler last weekend is disgusting. Surely, amongst the elected representatives of South Australian's there must be those who have the morals, ethics and integrity to stop this situation and stop the actions of a runaway train.

You would be well aware of the South Australian situation regarding, as described by the SA Premier, "The Bikie Laws". Interestingly, once again we have direct reference to "bikies" yet the legislation makes no reference to the word whatsoever.

While researching the current 'order' against The Finks I had occasion to read the South Australian AG's dissertation to Parliament on 3 February 09 at 1601 hrs. (Attached - AnnextoSOCO502009.pdf) We would refer you to the first sentence and further note the date of 16 Dec 08 as being when he received the application from the Police Commissioner. If you then look at the Application_Finks file (Attached) which was made by the Police Commissioner and check the properties you will note the application WAS NOT CREATED until 17 Dec 08. There is simply no way the AG would get the date wrong - this is a test case and will have been rigorously and robustly rehearsed. There is a very, very obvious problem. This is a very serious matter.

If you then look at the jpg's in numeric order of the file designators you will see the response to a submission put to the South Australian AG by the Brisbane Chapter of XXXX XXXXXX. The response is exactly the same response received by EVERY PERSON who wrote a submission. For interests sake, we undertook a mathematical exercise using the figures supplied regarding criminality by the AG on the information sheet.

If you go to the spreadsheet 'percentage analysis of offences" you may well be interested to note the results of this analysis - using SA AG supplied figures - is that AFTER BECOMING a member of the Finks, the offence rate DROPPED by an average of 72.62% (See cell H9 – 27.38% subtracted from 100%). The answer we expect is "they learn how not to get caught when in the Clubs" - what crud. Is it at all possible that the discipline and control of the Clubs over members reduces crime by individuals?

Why, I wonder, is there a concerted attempt to marginalise, vilify and eradicate (dare I say engage in genocide upon - check the dictionary) OMG Clubs? NSW has analysed crime and attributes 0.6% to OMCG. **ZERO POINT SIX PERCENT.** What, pray tell, is being done about the other 99.4% of crime (assuming the 0.6% figure will probably be close to a benchmark.)

OMG's have a number of people in them who commit offences. Just like any other group of people would have. However, the current actions of outlawing an organisation are abhorrent. The same rules could apply to the Masonic Lodge which has well documented and researched criminal elements with sections of it (P35 and the London Lodge). Would the same rules of serious criminal behaviour apply to the Directors of Australia's two largest cement companies who conspired to price fix and defraud Australians of millions of dollars? (They were convicted) Does the same rule apply to Magistrates or Police as a group who have clearly documented cases of serious and organised crime convictions? If you analysed convictions of Public

Servants and Police over the same periods and in the same categories in which the Finks have been analysed I dare say one may need to Outlaw the Public Service and Police. Senate Inquiry into SOC

Is well worth while looking at. It is the Senate Sub Committee on Organised Crime submissions and Hansard reports of public hearings.

The terms of reference of the Committee are;

Inquiry into the legislative arrangements to outlaw serious and organised crime groups with particular reference to:

- (a) International legislative arrangements developed to outlaw serious and organised crime groups and association with those groups, and the effectiveness of these arrangements;
- (b) The need in Australia to have legislation to outlaw specific groups known to undertake criminal activities, and membership and association with those groups;
- (c) Australian legislative arrangements developed to target consorting for criminal activity and to outlaw serious and organised crime groups, and membership of and association with those groups and the effectiveness of these arrangements;
- (d) The impact and consequences of legislative attempts to outlaw serious and organised crime groups and membership and association with these groups on:
- (i) society
- (ii) criminal groups and their networks
- (iii) law enforcement agencies
- (iv) the judicial/legal system.
- (e) An assessment of how legislation which outlaws criminal groups and membership of and association with these groups might affect the functions and performance of the Australian Crime Commission.

You will note that Outlaw Motorcycle Groups (OMG's) are not mentioned in the terms. A search of public domain available data reveals 375 recognised Organised Crime Groups in the world. One would suggest that the activities of these groups are what the inquiry ought be looking to.

We undertook a research task by downloading every submission and Hansard and running a word search of the 375 recognised organised crime groups and a word search of what we saw as 'key words' regarding OMG's. I have attached a copy of the data sheet (verbage matrix) for your reference.

Interestingly OMG's featured 612.12% more than the areas the terms of reference directed the inquiry to.

One may well ask a number of somewhat awkward questions, indeed has this inquiry actually breached its own terms of reference and be taken either intentionally or unintentionally away from its task.

The submission made by the Victorian Police is very interesting and I would recommend the reading of all information by various eminent Academics and Civil Liberties Groups.

SA Parliament Hansard

With respect, the Legislation being created and passed in South Australia disrespects the hundred thousand Australian Servicemen and Women who died protecting the World from autocratic despots. The real threat

The rise and rise of new gangs [BP - NOTE-"GANGS" (should we also ask about Triads, Yakuza ??)]

THEY call themselves MBM - the Muslim Brotherhood Movement - a gang of 600 men who boast they are the toughest and best young street fighters of Middle Eastern descent in Sydney.

MBM claims to be the biggest of four new gangs to emerge on Sydney streets in the past year. Its numbers rival those of the state's largest bikie gang, the Rebels.

The sudden appearance of MBM, with its growing membership recruited predominantly from the city's south-western suburbs, has alarmed senior police already battling to combat open warfare among outlaw motorbike gangs.

Even hardened private security guards have expressed concern to police about the indiscriminate "punch and run" tactics of MBM members who, in the past two weeks, have arrived in large numbers at city nightclub venues and who walk the streets in intimidating mobs. But the objectives of MBM - its emblem features two crossed pistols and a hand grenade - and its leadership remain unclear to officers of both the Organised Crime and Gang Squad and Middle Eastern Organised Crime Squad.

Police say that a fortnight ago MBM members embarked upon a campaign of random assaults on men who crossed the path of a mob of about 100 toughs stalking Darlinghurst and Kings Cross during the Gay and Lesbian Mardi Gras.

A week ago about 30 MBM members intimidated private security guards at government car auctions at Smithfield.

The emergence of MBM also coincides with the rise of two other urban Sydney gangs - the Parra Boyz or Asesinoz MC and Brothers For Life or BFL.

Police say BFL - with a logo featuring crossed machine-guns - is not dissimilar to MBM in its extremist views, but membership numbers are unknown. Police describe Asesinoz, comprising teenagers of Middle Eastern decent, as "tough kids" who use the video-sharing website YouTube to promote Islamic extremism and anti-Australian actions such as flag burning.

The group, which recently changed its name from the Parra Boyz, has more than 40 members, some of whom are known to police for committing acts of violence and vandalism.

Its creation follows that of the Notorious bikie gang, comprising members of Middle Eastern and Pacific Islander extraction, more than a year ago after a split in the membership of the Nomads motorcycle club
