

COMMONWEALTH/STATE DISABILITY AGREEMENT

CLAUSE 1(2)

the Commonwealth of Australia

and

the State of Victoria

in relation to

service outlets, associated funding and timetable for transfer of services, property, equity and resources in the State of Victoria.

DOCUMENT 2

This Schedule (the Schedule) is made pursuant to Part 1, Clause 1(2) of the Commonwealth/State Disability Agreement (the Agreement), signed by Heads of Government of all States and Territories and the Commonwealth at the Special Premiers' Conference on 30 July 1991. This Schedule, signed by the relevant Commonwealth and State Ministers, is attached to the Agreement and forms part of the Agreement.

A. ADMINISTRATIVE ARRANGEMENTS

- 1(1) The Commonwealth of Australia (the Commonwealth) and State of Victoria (the State) have agreed to the administrative arrangements stated hereunder. The service outlets and their associated funding, property and equity that are to be transferred by the Commonwealth to the State and vice versa are specified in Items B and C of this Schedule.

DATE OF EFFECT

- 2(1) In accordance with clause 1(3) of the Agreement the administrative arrangements specified in Item A shall commence to operate on and with effect from 1 July 1992 unless otherwise specified in this Schedule.
- 2(2) All payments under the Schedule [other than transition payments pursuant to Item A paragraph 3(2)(c)] shall be paid on or after 1 July 1992.
- 2(3) On and from 1 July 1992 those services and grants totalling \$12,216,107 which are transferring to the Commonwealth and specified in Item B are approved in accordance with the Commonwealth's Disability Services Program.
- 2(4) On and from 1 July 1992 those services and grants totalling \$50,961,789 which are transferring to the State and specified in Item B are approved in accordance with the State Government's Disability Program.

FINANCIAL ARRANGEMENTS

- 3(1) The Commonwealth will provide funds to the State as a specific purpose payment in accordance with the "Payment Arrangements" in the Attachment to the Agreement. Agreement to any alternative payment arrangement may be made in the context of a future Premiers' Conference or other multilateral process.
- 3(2) Payment amounts will be equivalent to the net full year effect of the amount provided in 1991-92 to support transferring services (transfer base payments) and to provide for growth in services (growth payment) and transition of existing services (transition payment).

- 15(3) The Commonwealth agrees to provide funds through Financial Assistance Grants to the State to meet the accruing employer superannuation liability (exclusive of the Superannuation Guarantee Levy) for agreed Average Staffing Level to the State at the rate of 12.4%. The final sum is to be agreed when the conditions referred to in sub clause 15(2) are completed.

#### PROPERTY AND EQUITY

- 16(1) In accordance with Clause 11(3) of the Agreement, each level of government will assist the other level of government to realise any equity contained within Item C on a case by case basis. The assistance will be in accordance with any past grant funding arrangements or agreements applying to that property or equity.
- 16(2) Where a service is transferring to the Commonwealth and operated from land held by the Crown in right of the State, the State agrees to consider compensation if that service is relocated to a more appropriate location. The compensation could be in the form of capital purchase or assistance in rental costs.

#### EFFICIENCY DIVIDEND

- 17(1) As specified in the Attachment to the Agreement, there will be a one-off efficiency dividend of 2.5 per cent from both the Commonwealth and the State base for administration following the completion of the rationalisation. This money is to be redirected into service delivery for people with disabilities.
- 17(2) The Commonwealth and the State will, by 30 December 1992, determine an agreed procedure for achievement of the respective dividends.
- 17(3) The Commonwealth and the State will each implement the agreed procedure for achievement of the respective dividends.

#### INDEMNITY CLAUSE - NEGATION OF LEGAL CLAIMS

- 18(1) The Commonwealth indemnifies and shall keep indemnified the State from and against all actions, claims, demands, costs, and expenses (including the costs of defending or settling any action, claim or demand where such costs include legal costs and expenses on a solicitor and own client basis) made, sustained, brought or prosecuted in any manner based upon, occasioned by or attributable to any liability which may arise from or be a consequence of the administration by the Commonwealth of any service which is transferring to the State from the Commonwealth pursuant to the Agreement.

- 18(2) The State indemnifies and shall keep indemnified the Commonwealth from and against all actions, claims, demands, costs, and expenses (including the costs of defending or settling any action, claim or demand where such costs include legal costs and expenses on a solicitor and own client basis) made, sustained, brought or prosecuted in any manner based upon, occasioned by or attributable to any liability which may arise from or be a consequence of the administration by the State of any service which is transferring to the Commonwealth from the State pursuant to the Agreement.
- 18(3) These indemnities are continuing obligations separate and independent from the other obligations of the parties and survive termination of the Agreement.
