QUESTION 1

Senator Siewert asked:

How did the Department derive the figure of an estimated 5,000 people to benefit from Special Disability Trusts over four years (noted on page 5 of its submission to the Inquiry)?

Answer:

The estimated figure of 5,000 is derived from an analysis of the people reported to have a profound core activity limitation (Survey of Disability, Ageing and Carers 2003: Australian Bureau of Statistics) and Centrelink data regarding the number of people in receipt of Disability Support Pension (DSP) being cared for by their parents, and/or people who had high care needs and were unlikely to be able to manage their own affairs.

From this source was derived the number of parents who would be able to gift and set up a Special Disability Trust based on a number of assumptions about their characteristics such as homeowner status and level of assets. It was assumed that there would be a greater disposition to set up a trust as the level of assets increased.
