To Members of the Senate Enquiry.

The attached information is material that I personally have researched & collected from our various relevant Accounts, Supermarket Dockets & Credit Card Statements. The motivation for the exercise was a study done by myself in year 2006 which showed that the GST cost to us was some 4.8% & this has a greater impact on those of us on "fixed incomes" than the Household where the income is much higher.

My Wife & myself, both aged 80 years live in a Retirement Village consisting of some 300 residents most of whom occupy "Independent Living Units", with the remainder living in "Serviced Units" The "service fee "we pay to live in the Village attracts a GST of some 10 %which equals \$27 per month.

I believe my wife's & my situation is typical & for the people living on "Fixed Incomes," that income coming from Investments or Aged Pension.

I trust the material I present in this Correspondence will be of some help in the Enquiry. I sincerely believe that a significant percentage of "Aged People of Australia" are living in "stress" because of their Financial position & in particular the effect of the GST on that financial position.

These figures show how "meaningless" the CPI figure is to our age group since Supermarket spending is clearly the major component of our expense & this is an essential expense. Overseas trips etc. may or may not have reduced in cost but this irrelevant to our age group.

This represents a 23.9 % increase in our spending on "essential foodstuffs. The shopping was at the same local district Supermarkets each year.

SUMMARY.

1. While the Supermarket GST was an average of 4.1 % the other items averaged 9.1 % & these are absolutely essential expenses for living.
