I just received your letter advising me of the rate increase of my Smartpower meter; it's not even a small increase but quite a substantial one. I strongly object to this increase and think it's grossly unfair as I have paid a lot of money just to get this meter installed so I could save some money on electricity. Why is it that only the rates for Smartpower meter people has been increased and not an increase across the board for everyone which would be the only fair thing to do?
