

EMPLOYMENT AND TRAINING STATISTICS 1987-88, 1990-91

1. The DEET submission acknowledged that the registration rate for people with disabilities was 'not high and any improvement in services and programs would be likely to lead to a higher registration rate'.¹ At the end of June 1988, some 86,400 people with disabilities were unemployed and awaiting placement, (8.7 per cent of all those unemployed and awaiting placement), 39 per cent of whom had been registered with the CES for over 12 months which may reflect the difficulties people with disabilities face in obtaining jobs.
2. During 1987/88, 86,200 people with disabilities had registered with the CES, 60 per cent of whom were aged 21-44 years. While the majority of these were unemployed, 9,400 were seeking alternative employment or part-time employment. Sixty five per cent of registrants with disabilities received referrals (to vacancies) however only 21 per cent of all such registrants were successful in obtaining placement in employment. This represented 2.5 per cent of total placements for 1987/88.
3. Only 11,852 commencements, or 11 per cent of all commencements in 1987/88, in labour market programs identified themselves as disabled. JobStart was the program most frequently utilised in assisting people with disabilities. Close to two-thirds of all commencements by people with disabilities were in the JobStart scheme. Just under one quarter of commencements by people with disabilities were in the Adult Training Program (ATP) and Youth Training Program (YTP).² The Community Training Program accounted for 12 per cent of commencements by people with disabilities.³ SkillShare commenced operation on 1 January 1989 combining three pre-existing community based programs – the Community Youth Support Scheme (CYSS), Community Training Program (CTP) and Community Volunteer Program (CVP). As a result the data in Tables 5-11 reflect the level of participation in training programs by people with disabilities in the period immediately before the introduction of SkillShare.
4. It should be noted, however, that Table 7 demonstrates that people with disabilities accounted for only 16 per cent of all JobStart commencements and

10 per cent of all ATP and YTP commencements compared with CTP where just over one quarter of all commencements were people with disabilities.

- The high usage of JobStart may reflect the use of the subsidy by CETP and SE services in placing their clients in open employment.
 - The relatively high level of participation by people with disabilities in the CTP (one of the forerunners of SkillShare) reflects the dedication of 14 of the 77 projects then funded under CTP specifically to the needs of people with disabilities.⁴ This relatively high level of participation in CTP appears to have been maintained in some of the community based SkillShare programs.
5. Males with disabilities had a higher rate of commencements in labour market programs as opposed to the rate of commencements for all males (Tables 8 and 9).
 6. Tables 10 and 11 illustrate the experience of those who participated in labour market programs during 1987/88 three months after they had completed the program. Almost one quarter of those who completed a CTP programs were employed three months after completion, 67 per cent were unemployed, 7 per cent were in subsidised employment and 3 per cent were in education or training. Over half of the JobStart completions were still in employment 3 months later, while 44 per cent were unemployed, 2 per cent were in subsidised employment and 1 per cent were in education or training. However people with disabilities who had participated in the ATP or YTP were more likely to be unemployed (67 per cent) 3 months after completion than other participants (73 per cent).
 7. Table 12 shows that only 2 per cent of traineeship commencements since 1985 were by persons who identified themselves as having a disability. It should be noted that this scheme is targeted at 16-18 year olds. DEET noted in its submission that participation by this group was 'broadly in line with its representation in the youth labour force'.⁵ By 30 June 1990 44,500 young people had begun a traineeship since its commencement in 1985.⁶ However, participation rates for people with disabilities had dropped since 1987/88 to 1 per cent. The Annual Report also notes that several surveys had shown that trainees in the disadvantaged groups (which includes people with disabilities) had a high employment rate (79 per cent) 3 months after completion of their traineeship. This is only slightly below the overall retention rate of 87 per cent in employment three months after completion of training.

STATISTICS FOR EMPLOYMENT AND TRAINING – 1990-1991

STATISTICS FOR EMPLOYMENT AND TRAINING 1990-91

1. Registration numbers for people with disabilities had increased, and at 30 June 1991 had totalled 184,759 (including 20,891 persons seeking alternative or part-time employment) for 1990-91.
2. At 30 June 1991 some 144,121 people with disabilities were listed as unemployed and awaiting placement (Table 1). The majority of these (totalling 107,451) were in the age groups 25-44, and 45+ (Table 1). Males aged 25-44 totalled 48,162, and males aged 45+ totalled 34,051; females aged 25-44 totalled 16,686 persons and females aged 45+ totalled 8,552 persons.
3. Males aged 25-44 represented 11.99 per cent, and males aged 45+ represented 12.65 per cent of disabled persons registered over 12 months with the CES. Females in the same age groups represented 9.06 per cent and 6.36 per cent respectively. However, males aged 25-44 represented 44.02 per cent of unemployed and CES-registered men with disabilities, and women with disabilities in the same age group comprised 38.35 per cent of unemployed and CES-registered women with disabilities at 30 June 1991 (Table 3).
4. JobTrain Preparation (17.2 per cent) and JobTrain Other (15.9 per cent) were utilised well by people with disabilities, as was JobStart (19.1 per cent) and Special Intervention (31.6 per cent) – the last in spite of the fact that it does not cater specifically for people with disabilities (Table 7).

This is a percentage increase over 1987-88 figures, though variations in program expenditure/utilisation may often lead to percentage increases in take-up by selected groups while actual numbers of people using the program may decrease.

5. SkillShare take-up totalled 8,249 people with disabilities (8.7 per cent) out of a total of 94,284 participants (Tables 5 and 6).

It will be interesting to see if SkillShare participation increases during 1991-92, from a relatively low 8.7 per cent, given the recent emphasis on DASUs and a disability strategy for the program.

6. Table 9 indicates that men with disabilities participated in all labour-market programs at a higher rate than all males, whereas women with disabilities participated at a lower rate. This may suggest there is a need for special access projects for women with disabilities. Both SkillShare and JobTrain (Other) appeared particularly useful to both men and women with disabilities, especially for those in the 25-44 age group (Tables 5, 7, 8).

7. However, Table 10 demonstrates that Non-DEET outcomes (PPM – Post Program Monitoring)⁷ for people with disabilities are not promising (for example, 60.3 per cent unemployed from Skillshare, and 16.4 per cent not in the labour force). When further education and training are taken into consideration, Skillshare (with a PPM response rate of 72.5 per cent) had a 36.1 per cent positive outcome. JobStart (with a 67.3 per cent response rate) had a 59.8 per cent positive outcome. This was almost the same as the 'All Persons' outcome (Table 11) of 57.3 per cent.
8. Table 12 indicates that people with disabilities utilised other DEET programs after completing the original program, at a level of 8.3 percent. This was higher than the 'All Persons' participation in further DEET programs of 6.9 per cent (Table 13).
