To Senators on the Senate Select Committee on Climate Policy,

As a responsible member of the world community, Australia should be setting a good example on the reduction of greenhouse gas emissions. Emissions trading is one important tool that the government can use to reduce Australia's emissions. We need to set strong targets and it is possible to do this by having a well-designed scheme that will dramatically reduce Australia's emissions at the least cost to the economy and make sure Australia does its fair share to tackle climate change.

I am totally disillusioned by the proposed Carbon Pollution Reduction Scheme (CPRS). It is a badly designed scheme that will be worse than useless.
