CLERP 7 - Submission to Economics Legislative Committee (Dated 25 March 2003)

Do the new forms simplify document lodgment and compliance procedures?

In our view, the new forms have increased the level of complexity, compliance and reporting and in fact the processing time actually spent reading the instructions, collecting and providing the information has significantly increased. The following example demonstrates the increased level of compliance and reporting requirements.

Key issues:

The small business owner would need to lodge 13 forms with the ASIC according to the new rules compared to existing rules requiring 6 forms. It is also noted that the each time a form 484 is completed, the company director needs to review 19 pages compared to 5 pages (Forms 203, 207, 284, 304).

Additional reporting requirements

Two new forms (489 and 490) have been introduced for foreign companies and registered schemes. As a result, if there is a change of office hours, address or change to officeholders the company secretary/ director will need to complete up to 3 section of the for 484 or one or both of forms 489 and 490 for companies affected.

Form 362 increases the workload for agents, as they need to lodge a separate form for all new appointments. Previously Form 361 allowed agents to be appointed as an agent for multiple companies on the one form.

Ultimate Holding Company information

Increased workload for reporting Holding Company changes. Example. ABC is a holding company for 30 subsidiary companies. If a holding company changes its name then the company secretary/ director must complete and lodge 30, 484 Forms.
