NATURE OF POTENTIAL CONFLICT OF INTEREST

- 1 A person, or a member of his or her immediate family is a Director or office-holder of a company or organisation under consideration as part of an application.
- 2 A person, or a member of his or her immediate family has a shareholding, greater than 5% in a company or organisation under consideration
- 3 A person, or a member of his or her immediate family or his/her employer has an involvement in the application under consideration;
- 4 The company or organisation under consideration is a direct competitor of an entity in which a member, or a member of his or her immediate family holds shares, holds office or is employed
- 5 The employer of the person, or the employer of a member of his/her immediate family is an entity which is a shareholder/partner/parent company or organisation of the company or organisation under consideration;
- 6 A person, or a member of his or her immediate family or his/her employer has a current contractual relationship with the company or organisation under consideration
- 7 A person, or a member of his or her immediate family or his/her employer has a past contractual relationship with the company or organisation under consideration
- 8 A person, or a member of his or her immediate family was employed by the company or organisation under consideration but not within the previous two years;
- 9 A person, or a member of his or her immediate family was employed by the company or organisation under consideration within the previous two years (but not currently);
- 10 A person, or a member of his or her immediate family has an informal relationship with the company or organisation under consideration through an industry association or similar body;
- 11 A person, or a member of his or her immediate family is a member of a superannuation fund, the member, and the member or a member of his or her immediate family is unable to exercise any control over the shareholdings and fund holds shares in the company under question
