The Victorian Forest Harvesting and Cartage Council represents 140 harvesting and cartage contractors working in both Native Forest and Plantation in Victoria. The contractors range in size from owner operators to small businesses employing 60 people.

**H**arvesting

These contractors are small businesses with significant investment in plant and equipment. An owner operator cartage contractor will have a minimum investment of \$350000 and a single crew mechanical harvesting operation will command a minimum investment of \$1.3million. About 700 persons are directly employed by these contractors.

Cartage

The Owner Drivers and Forestry Contractors Act 2005 was passed by the Victorian Parliament to try and address the findings of the Industrial Relations Victoria Report of Inquiry into Owner Drivers and Forestry Contractors. The Report found that Owner Drivers/Forestry Contractors were subject to lack of adequate information on their business cost structures, contract insecurity, harsh or oppressive commercial terms and practices and had a strong need for alternative, low cost commercial dispute resolution.

The Owner Drivers and Forestry Contractors Act 2005 does not apply a labour law styled-solution to owner drivers/forestry contractors. Instead it accepts that contractors are small business operators and deals with them within a framework

of commercial and fair trading laws.
