HMAS WESTRALIA

QUESTION 1

ACTION AREA: Navy

Senator Hutchins

What happened to the remaining sailors onboard HMAS WESTRALIA, ie how many stayed, how many left, if they left where did they go and when.

RESPONSE


71 sailors were posted to WESTRALIA at the time of the fire; four others were listed as being onboard but were not posted to the ship.

Nine sailors were posted from WESTRALIA within three months of the fire, ie by 31 July 1998. Three of these were posted to other Fleet Base West ships and the other six to various shore establishments. These would not have been planned postings as WESTRALIA was due to deploy at the time of the fire. The postings would have been a combination of a response to the sailors' requests to leave the ship and the need to move some personnel to higher-priority sea positions once it was clear WESTRALIA would be out of action for some time.

11 sailors were posted off between 1 August 1998 and the end of that year. Three were posted to other Fleet Base West ships and the remainder to shore establishments for similar reasons to the earlier post-outs, ie a combination of personal preference and emerging higher-priority needs.

51 personnel remained with WESTRALIA past the end of 1998 and were posted in due course in the normal sea-shore rotation cycle. The majority of these personnel departed throughout 1999-2000 with nine members posting off during 2001; the last sailor discharging to shore in January 2002.

Of the 71 WESTRALIA sailors 27 remain in the Navy and 44 have discharged. Approximately half of those discharged joined the Naval Reserve and hence Navy still has some contact with them. Some have since returned to part-time or full-time Naval Reserve service.
