Disciplined, focused hard work and experienced economic management has seen the Australian economy grow considerably. In fact, our economy has grown more strongly than most countries in the developed world. That means Australian Government funding to all the States and Territories will grow by \$2,783.5 million in the coming year.

The growth in the economy means that extra money will flow to the States and Territories and that each State can now receive more.

Since the introduction of the New Tax System on 1 July 2000, every State and Territory will be better off than without tax reform - over \$1,620 million better off in the coming year.

As a result, we should all expect to receive better services from our State Governments.

>More Funds for the People of Victoria

Victoria is set to receive \$11,458.9 million from the Australian Government in the coming year, including a \$237.9 million bonus from tax reform.

That's \$11,458.9 million that can be spent

on better local hospitais, moré police, better schools, better roads, better services or abolishing state taxes.

As part of this funding, the Australian Government also provides special payments to each State and Territory for education, health and transport.

Victoria will receive: \$2,063 million for education \$2,123 million for health \$286 million for transport

That amounts to a fair go for all Victorians



That's because the Australian economy has grown.

In fact, our economy has grown more strongly than most countries in the developed world.



GST funding to Victoria, since the GST was introduced has grown every year. This financial year it will be \$8,792 million. Next year it will be well over \$7,000 million.

>Record Funding for the People of Victoria

In the coming financial year, the Victorian Government is set to receive an extra \$545.7 million from the Australian Government. In total, Victoria will receive over \$11 billion that can be spent on better hospitals, more police, better schools and better roads.



That's another reason why the Victorian Government should honour it commitment to build the Scoresby Freeway - without toils.

>Every Cent to the States

The Australian Government has also kept its promise to

make sure that every cent of the GST goes to the States and Territories. Since the new tax system was introduced in July 2000, Victoria has received more than \$22 billion over 4 years from the GST atone.

>The Independent Umpire

The Independent Commonwealth Grants Commission makes recommendations on dividing up GST funds between the States.

This is based on a simple principle of fairness that every State should have the capacity to provide the same standard of service to every Australian and matter where they five.

In 1999, Victoria signed an agreement to abide by the decision of the Independent Umpire.

Now it wants to go back on that agreement.
