S. Boughey, identified there were 31 election promises in Tasmania, - 7 of these projects had come through TEAC - RP projects. Suggested that a clear delineation be made between "RP - promises" and RP "real projects"

The election promises would not affect the RP allocation in Tasmania.

Regional Directors spoke of their concerns and the affects that the election promises were having in their discussions with community groups.

The Directors felt that their commitment to commenting on RP projects had been undermined, and that a breach of conduct, had occurred whilst in Caretaker mode — by the politicians.
