Director's Report - David Ross

Senate Inquiry into the relationship between CLC and Centrecorp

There is a Senate Committee inquiry into the relationship between Centrecorp and Central Land Council. The committee hearing will take place in July.

Representatives of CLC, Centrecorp and Audit are required to attend the hearing.

CLC owns three of the five \$1 shares in Centrecorp (Tangentyere and Congress have one share each). The shareholders do not own the assets of Centrecorp. Centrecorp is a trustee. There are two trusts. The beneficiaries are generally children from schooling, education, and sports etc. The three shareholders can not benefit from any monies made by those trusts or the businesses that operate within those trusts.

We will attend the Committee's hearing to give the information we are obliged to give. We are happy to go along.

An allegation was made in the last Senate Committee hearing that the CLC has been diverting money to a 'Warlpuri trust', and to general Motors Acceptance Corporation, a finance company owned by General Motors.

CLC staff corrected the Senator by explaining that 'GMAAAC did not stand for General Motors Acceptance Corporation, but 'Granites Mine Affected Areas Aboriginal Corporation'.
