

Being a user of Open Source Software should be sufficient to allow me to object to the way that the Eree Trade Agreement in its present form is permitting encroachment on the freedoms that we, the users and developers of this technology now enjoy. Being one who also helps others, also introducing many to enjoy the great pleasure, versatility, lack of restriction, freedom, encouragement and ability to configure as they will their computers, without fear of prosecution or persecution. I feel a duty to request a careful and sensible review of the Free Trade Agreement especially pertaining to Open Source. Software which is being jeopardized by the agreement in its present form.

There are corporate lawyers that can argue the points of law, and the information about how to best avoid the danyers inherent in the present documentation. These are also able to show what losses might be expected, and how these things will impinge upon business, large and small. But I wish to make the point that Open Source Software is what will make Australia both competitive and ahead of its time. Young Australians are being taken under the wing of this technology and making it their own, enjoying, without restrictions both the freedom and challenges that it encountees. The tools are included to make it the best and fairest software in the world. Allowing any of them to work with it without living in fear of encroaching on, or being prohibited from contributing. This is not the first or last time that Australia will be asked to give up something for a Free Trude Agreement, being so in name only. We who use and teach others, especially older people to use this cooperative technology also wish to retain a true freedom in Open Source Software. Without interference Open Source Software is working. It certainly offers a greater choice, and many are finding, a better option to that which is already advantaged too greatly.
