June 2003	Telfer Infrastructure Corridor Agreement	<ul style="list-style-type: none"> - Individual heritage concerns of claimants groups addressed - Monetary compensation and community benefits in recognition of industry impact on native title rights and interests - Provision of training programs to maximise claimant employment in industry
May 2003	Peak Hill Manganese Agreement	<ul style="list-style-type: none"> - Recognition of native title rights and interests over 45 000 sq/km - Financial compensation, employment opportunities and Aboriginal Heritage Protection - Required environmental clean-up and rehabilitation of region by Industry - Industry recognition and protection of sites of cultural significance
March 2003	Tallering Peak Iron Ore Project Agreement	<ul style="list-style-type: none"> - Industry conducted heritage survey in conjunction with claimant elders and provided heritage monitoring - Exclusion zones were placed around culturally significant sites - Tallering Peak was not to be disturbed or knocked down - The Indigenous community to receive royalty payments for the life of the mine - Employment, training and economic development opportunities - Support for education, law and culture of the indigenous community - Recognition of traditional ownership of the region

October 2002	Mining and Cooperation Agreement	<ul style="list-style-type: none"> - Process ensuring Aboriginal Heritage concerns are addressed in a manner least disrupting to Industry
May 2002	Minjar Gold Project Agreement	<ul style="list-style-type: none"> - Recognition of cultural entitlements of the Badima people in a formal agreement - Aboriginal claimants ensured tenement access and monetary compensation - Provision of employment opportunities for Badima people - Commitment to conduct cultural awareness on site
August 2001	Mount Gibson Iron Project Deed	<ul style="list-style-type: none"> - Mining company to take all reasonable steps to protect heritage sites - Claimants agreed to facilitate project development - Monetary compensation and employment contracting opportunities for the claimant group
March 2001	Land Use Agreement for Wodgina Mine	<ul style="list-style-type: none"> - Acknowledgement of traditional ownership of the land - Heritage protocol developed - Monetary compensation provided to claimant group - Employment opportunities and preferential treatment of claimant tenderers

????1999	Cultural Heritage Management Agreement Between AGL Pipelines and Western Power Corporation and Badima Native Title Group	<ul style="list-style-type: none"> - Protection and management of cultural heritage during the construction and operation of natural gas pipeline - Provision for employment and training of Badima heritage monitors to supervise construction of the pipeline - Provisions ensuring protection of significant sites

Rio Tinto Exploration – Regional Heritage Agreement	<ul style="list-style-type: none"> - Rio Tinto Exploration Pty Ltd to comply with Aboriginal Heritage protection procedures in relation to exploration activities on existing and future tenements within Native Title claims represented by YMLSC - All work done on tenements must comply with the provision of the <i>Aboriginal Heritage Act 1972</i> - Native title claimants agreed not to object to the use of expedited procedure in the grant of future exploration tenements

Rio Tinto Iron Ore Heritage Agreement	<ul style="list-style-type: none"> - Procedural framework established in relation to the conduct of Aboriginal Heritage Surveys within claims represented by YMLSC - Framework designed to ensure mining and exploration interests progress while respecting traditional laws and customs of the native title claim groups as required by <i>Aboriginal Heritage Act 1972</i>

Giralia Regional Exploration and Heritage Agreement	<ul style="list-style-type: none"> - Giralia to enter into Aboriginal Heritage Agreements in relation to each ungranted exploration tenement application within native title claims represented by the YMBBMAC. - All work done on tenements must comply with the provisions of the <i>Aboriginal Heritage Act 1972</i> - The native title claimants agree not to object to the use of the expedited
