
Dear Colin:

Dear Governor Bangertter

Thank you for your letter of 2 February 1988 with which you forwarded a copy of the Australia Commendation Resolution passed in General Session of the Utah State Senate. I understand a similar resolution was passed in the House. I was also grateful for the copy of your proclamation declaring 26 January 1988 'Australia Day' in Utah.

The last century has seen a great expansion in the bonds between our two countries. The alliance relationship between us had its origins in the Second World War, and the heroism displayed by Americans and Australians together in meeting the grave threat in the Pacific continues to hold an honoured place in our history. Today, apart from our defence links, we share important trade and investment ties; and we co-operate closely in many other spheres of activity including culture, and science, education and sport.

I was interested to read in your letter that the Utah Lieutenant Governor, Val Oveson, has undertaken mission work in Australia as have many others from your state. I am sure that the closeness of our connection is reinforced by such visits and also by the many families of Australian heritage who reside in your state. During Australia's bicentenary year, the Mormon Tabernacle Choir will participate in the Expo 88 in Brisbane, and a great many Australians are looking forward to hearing and seeing them there.

I should appreciate it if you would convey the appreciation of the Australian Government to the Utah Senate and Congress.
