I would like to inform the senate committee as a refugee living in Australia with my family all the promises by the Australian Embassy in Vienna after twenty four Years evidence discrimination, abuse, crimes against human rights and the crimes by the legal system against my family right to justice its not a surprise that the whole system is totally flawed, full of people with high education but disconnect with human civilization which in evidence crime against my family and systematic crimes and cover-ups against refugees and migrants on many occasions victims of war created by fanatics and corrupt politics. Politics never understand human rights, justice or respect for authors. Its only through dirty propaganda taking stories before media with no truth in its contents creating problems in culture religion and in the end push the wrong interpretation and mismanagement on people who have nothing to do, only to threaten the freedom by unconscious lunatics and fanatics secret service or police as the New south Wales government together with the corrupt GIO department done against my family in the past. When we asked for the truth in relation to assassination of our daughter in new south Wales's government hospital, multi damages against life all family including the children, stealing body and body parts was covered by the Newcastle coroner and her Majesty police treating as like criminals. The legal film which was suppose to represent us, instead was representing the corrupt including the corrupt legal system and helped in fabricating statement of crime for the arrogant Judge who happened to be a liberal.

After years of abuse, lies and cover-ups we start to recover stolen compensation just now and all cover-ups evident in the corrupt system. I would like to mention that we were involved in many inquiries by the federal government, New South Wales

government as well as the productivity commission in 1992 and 2004. In the Disability Discrimination Act we gave public evidence and more information about few submissions on behalf of my family, which can be found on the internet in relation to this enquiry where exists the truth and facts about the horrific crimes committed against my family in the new south Wales parliament in relation to inquiry and corruption in the supreme court protective commission.

In previous inquiries, there is clear evidence that the system have nothing to offer fro migrants and have nothing to offer for us; and I would like to explain that the crimes against the refugees begun since Vietnamese boat came, since the current prime minister came into government in particular his totalitarian view, a method used by German Gestapo which advocated fro illegal detention and deportation similar to communist soviet union, Stalin and KGB. And in the end hundreds millions of dollars wasted in destruction of human dignity and irreversible damages to the children and families with no reason and in the name of democracy which does not exist. In conclusion and opinion most intellectuals can be seen as the most dirty democracy built up with no limit to lying corruption and abuse of human rights.

Finally I would like to mention that we would be very happy to have a chance to openly explain the damages done to us, pain and suffering by the whole paranoia intolerance and unworkable system that is only committed to private financial benefit and unable to balance truth peoples rights and never understands anything, any body and don't understand themselves and never have any human feelings the people suffer, have to be mentioned at my polish consulate contact on few occasions since 1992, the federal government, police and the New South Wales government and Police. As I mentioned before the whole arrogance and ignorance, they stick only to propaganda to get more migrants by lying to them through corruption suck the money they have and destroying their lives how is it possible and then avoiding responsibility and talking rubbish about democracy on what they never understand.

In the final words I have to say that the legal and constitutional reference committee discriminated my family and abused my family right in the same way. And this surprise me how the inquiry was conducted and few years ago one of the senators was sent to Poland on a democratic forum which I understand whatever she said over there is rubbish and fraud interpretation I was informed too late as member of the Polish Solidarity I would like to stop the senator from attending because I know whatever was said is not true. I asked for transcripts many times but the senators office lied up


to today as I am and my family have a European Union citizen and we are entitled to protection through the European human rights commission which we inform all the time we wanted our case which we would like to be heard in the European Human right court against the government possibly the Governor general office and we believe maybe even against the monarchy. There is a crime in the whole evidence, which I have mentioned.

Am ready to give more evidence and witnesses to my claim if need be.
