What is the total staffing cost broken down by department?

Answer:

It is not possible to provide all the above details requested in the time frame, particulary in relation to costing broken by departments. In addition implementation planning is still occurring with not all communities having been surveyed. The number of additional Commonwealth staff may change over time and additional people may also be engaged as contractors or through service providers. The following information is provided for the major agencies involved in the Response by portfolio.

Attorney-Generals

Australian Crime Commission will engage an additional 16 people the majority will be located in the Northern Territory. Australian Federal Police have no new positions in 2007-08 but are seconding existing officers to the Northern Territory Police Force.

Defence

Defence are not engaging any additional personnel to undertake this activity but will utilise a mixture of 125 Reservists and 3 Permanent ADF members. The majority of these personnel are Northern Territory based.

Employment and Workplace Relations

There will be approximately 140 new positions in DEWR with staff for CDEP transition, management of the expansion of Work for the Dole and other employment programmes, contract and support staff and community employment brokers. Approximately 105 of these are expected to be based in the Northern Territory. A significant proportion of these staff are expected to be required for the transition period only. A further 10 positions will be created in Indigenous Business Australia (IBA). These IBA staff will be working with Northern Territory service providers to transition to the new arrangements, including assisting with business development.

Education, Science and Training

There will be around 17 new staff of whom 8 are expected to be based in the Northern Territory.

Families, Community Services and Indigenous Affairs

There will be approximately 150 new staff positions with about 75% of these staff based in the Northern Territory. These positions include Government Business Managers, support to the Emergency Response Taskforce and Operations Centre personnel.

Health and Ageing

There will be approximately 42 new positions in the Department. 15 of these positions are expected to be in the Northern Territory.

Human Services

Centrelink will have approximately 350 additional staff of whom 300 will be based in the Northern Territory. The Department will have 5 additional staff based in Canberra and Medicare Australia will have an additional 2 Northern Territory based staff.
