Subject: NT laws and addressing child abuse

Dear Senators and Senate Legal and Constitutional Affairs Committee

I write to express my concern about

- * the need for a response which takes the recommendations of the "Little Children are Sacred" report seriously
- * the haste with which these Bills have been introduced
- * the lack of time for consideration of the impact of the proposed laws
- * the lack of consultation with Indigenous communities

In these circumstances I urge you to

- * ensure that the Bills are reviewed properly on their merits: a key standard for this should be the extent to which thy are consistent with and take account of the recommendations of the "Little Children are Sacred" report
- $\ensuremath{^*}$ ensure that any Bills passed are consistent with the Racial Discrimination Act
- * withdraw changes to the permit system and land rights
- * ensure that given the lack of consultation with Indigenous communities and the high level of risk that hastily-passed legislation could be to the detriment of the people it affects any legislation is reviewed after a period of 12 months and b independently monitored on an ongoing basis

In deciding on your response I urge you to give full consideration to the Little Children are Sacred recommendations and to concerns being expressed by the people in communities which are affected such as
