

Dear Committee,

The main reason I am writing to you is to inform you of my feelings toward the new anti-terrorism laws, and to ask for your help in stopping them from being passed. Now I don't usually write these sorts of letters, but this is something I feel very strongly about; and you guys are really the only people that can help...

After reading the 107 page draft of the new legislation from Jon Stanhope's website (http://www.chiefminister.act.gov.au/whats_new.asp?title=What's%20New), I have to say that I full-heartedly disagree with it.
