It is stated in the Scriptures that God created man formed man of the dust of the ground, and breathed into his nostrils the breath of life; and man became a living soul, Genesis 2:7.

It is also stated in the Scriptures that God caused Adam to fall into a deep sleep whilst He removed one of Adam's ribs with which to fashion a woman, Genesis 2:21-23. Using a rib enforces the concept that a man and a woman shall stand side by side, not two men side by side, or two women side by side. "Getting the wood was another problem. There's a ban on cutting local trees in order to save the spotted owl. I tried to convince the environmentalists that I needed the Wood to save the owls. But no go!"

"When I started gathering the animals, I got sued by an animal rights group. They insisted that I was confining wild animals against their will. As well, they argued the accommodation was too restrictive and it was cruel and inhumane to put so many animals in a confined space".

"Then the EPA ruled that I couldn't build the Ark until they'd conducted an environmental impact study on your proposed flood".

Today

Consider 'The Roman Decadence'.
