# Additional Information supplementary to submission from Dr Jo Harrison regarding aged care issues, as agreed with Committee

I have listed below the organisations funded through the Commonwealth's Aged Care Advocacy Program, in each State and Territory. In addition I have given details of two additional organisations, in Central Australia, which receive funds from the Program to provide advocacy services as an element of their array of other services to specific groups.

I would stress to the Committee that as I outlined in my evidence, the impact on samesex couples who are over 65 years of age of the Centrelink arrangements following the passage of the Bill into law could be serious and devastating.

I urge the Committee to recommend that these devastating consequences be avoided by the implementation of special measures which acknowledge a lifetime of fear, anxiety and hiding on the part of same-sex elderly couples. A mechanism such as a sunset clause, grandfathering arrangements for same-sex couples over 65 in relation to pension matters, or, at the very least, a transition arrangement so that elderly couples have a significant amount of time to prepare for the changes, such as 5 years, is essential.

Further, I would also urge the Committee to prevent overpayments being raised against same-sex elderly couples should they not disclose until applying for residential care and be facing a retrospective overpayment from Centrelink if they do disclose in order to retain the family home. Again, the presence of a sunset clause or grandfathering arrangement must be guaranteed, so that more harm is not done to people who have already lived lives of trauma.

The government has a mandate to protect elderly people from harm – new aged care arrangements to enable complaints and investigations attest to this in the residential sector. Similarly, the amendments proposed this Bill must not cause harm to those upon whom it seeks to bestow rights. The prospect of elderly same-sex couples having to engage in lengthy appeals processes in relation to Centrelink is untenable. The prospect of them facing prosecution and investigation via third parties of their status as a couple, when they may never have disclosed to anyone other than each other is abhorrent in the extreme.

I thank the Committee for giving these issues the serious attention they deserve. I am confident that measures to protect elderly same-sex couples from harm can be put in place and appreciate the Committee's positive response to my submission and evidence.
